Message From The Chief of Police

The Leamington Police Service continued to provide quality policing services to the community throughout 2008.

Although Total Incidents decreased by 7% and Calls For Service dropped by 11%, overall Criminal Incidents increased by 21%.

Front line Patrol Officers and Criminal Investigators worked diligently throughout the year and enforcement increased in most areas. Criminal Code Charges increased by 23% and charges in relation to Drugs increased by 78%. As result of this enforcement, the total number of persons arrested and lodged in the police jail cells increased to 423 or 11%.

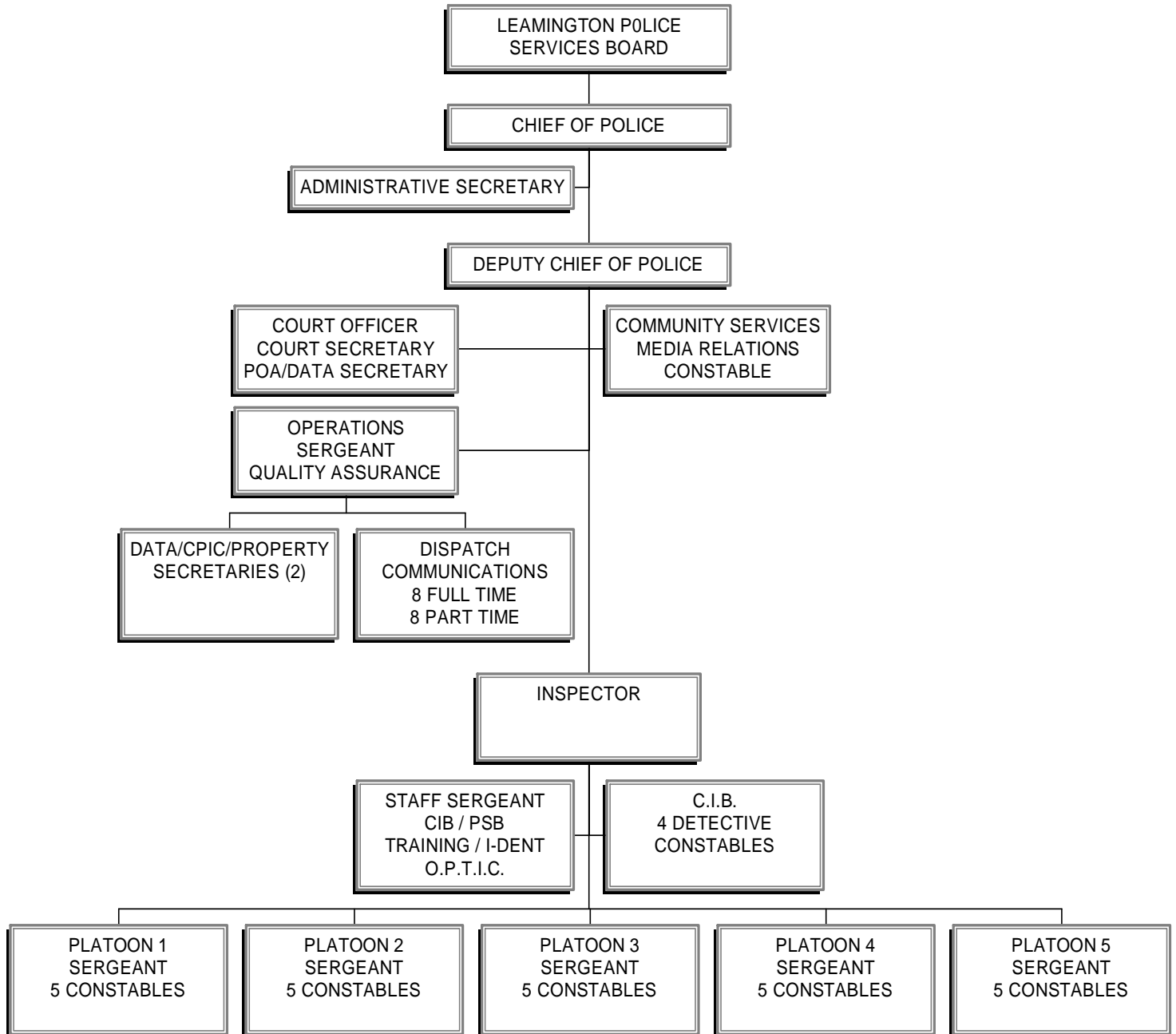
Staffing shortages that affected the police service in 2007 continued in 2008 mainly due to retirements and workplace injuries. The Police Services Board approved an increase to the police staffing in late summer and as a result, two new members will commence patrol duties in July 2009.

In September the Municipal Council made a request for a costing from the Ontario Provincial Police to provide contract policing to the Municipality. Members of the police service have coped with this unknown aspect of their future in a professional manner and await the results and decision.

I appreciate the performance of the members of the service as well as the support of the Board and look forward to opportunities for our police service to enhance the safety of our community in the coming year.

COMMUNITY SERVICES & MEDIA RELATIONS 2008

Schools

Involvement in the area's elementary and secondary schools continues to comprise most of the work done in Community Services. Several programs continue to be delivered which include Values, Influences and Peers (V.I.P.) (Grade 6), Race Against Drugs (Grade 5) and Bullying, Relations, Alcohol and Drugs (B-RAD) (Grade 9). These programs seem to take on greater importance every year due to the many new changes that the students face all the time.

Starting in the fall of 2008, Community Services started to spend time at the two secondary schools during the school lunch breaks every day. This has become very successful as the kids have now learned that police officers are an approachable and trusted part of the community.

Throughout the course of the year, Community Services has attended the schools to speak at career days, law classes, reading to kids and other drug and alcohol presentations.

Every Child Has Obstacles (E.C.H.O.)

Early in 2008, Community Services was approached by a group of parents in the community who were concerned about what seemed to be an increase in drug use among our teens. As a result, E.C.H.O. was formed. This group is made up of parents, police, clergy, a public health nurse, a representative from the schools and council.

Educate, Empower and Eliminate (E.E.E.)

This group was formed in May of 2008. It was made up of representatives from both school boards (Public and Separate), Leamington District Secondary School, Cardinal Carter and Kingsville District High School and Public Health.

The week of October 6th to the 10th was declared Drug Awareness Week at the three high schools. All the students attended an assembly each day where they learned something new about drug use and decision making. October 8th was Drug Awareness Night attended by approximately 500 parents and their children. Our special guest was former heavy weight boxing champion, George Chuvalo.

This entire program proved to be very successful and the committee continues to meet in 2009 to plan something for the fall.

Charity Hockey - The Leamington Police hosted the Legendary Hockey Hero's in their 8th annual hockey game on February 23rd and Cardinal Carter Secondary School on March 27th in our 14th annual charity hockey game. These hockey games continue to be very successful events, not only for the town and charities that the police department support, but the police officers themselves.

Internet Safety - This continues to be a problem that grows almost every day. Kids as young as 11 and 12 have now joined the popular internet site Facebook. There are many dangers associated with the internet. Community Services spends

time learning as much as they can so children and parents can be provided with as much information as possible.

Identity Theft and Frauds - These are probably the two quickest growing crimes that we are dealing with right now. With the economy being what it is, there are more and more requests for information seminars dealing with these issues.

Community Services and Media Relations

2008 CIB Annual Report

The Criminal Investigation Branch (CIB) is dedicated to investigating and solving serious crime, and targeting organized crime and recidivist criminals.

The CIB has four detective constables assigned to it and a Staff Sergeant supervising the unit. Officers who work in the CIB are drawn from the Uniform Ranks and then undergo an intensive period of training in law and the latest techniques in investigation.

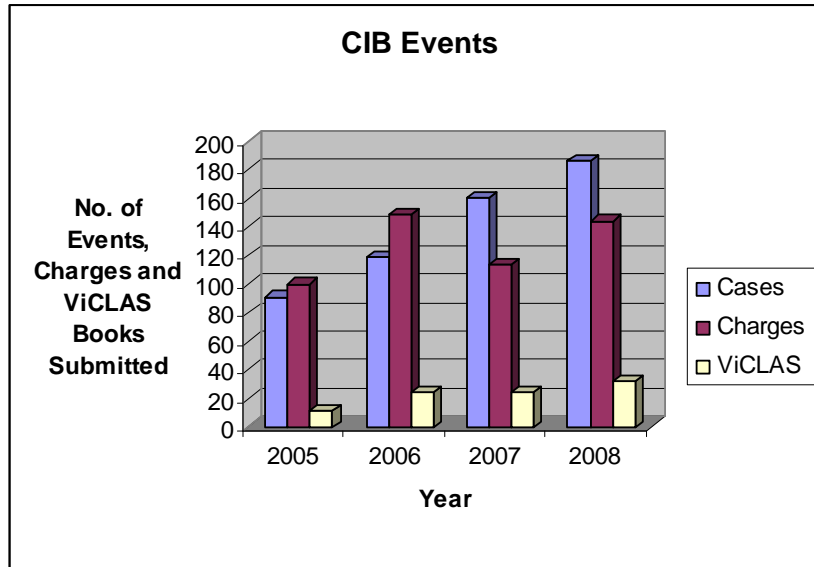
Their job is to investigate serious crimes such as homicides, violent offences, sexual offences, drug offences, crimes against society, and fraud.

2008 continued to be extremely busy for the officers assigned to the CIB. Collectively they investigated numerous threshold cases that are identified in our Major Crime Managements Plan as well as additional cases that needed extra effort. The CIB also receives all of the crime stoppers tips that relate to Leamington that often results in follow up assignments.

In 2008 the CIB investigated 186 events as well as an additional 248 Crime Stoppers Tips. Collectively the CIB laid 144 Criminal related charges. 2008 saw a 16.25% increase in the number of events investigated by the CIB officers as well as a corresponding 26.31% increase in the number of charges laid by the members in CIB.

Detective Constables are often called upon to give their expertise to patrol officers if they are involved in cases that are larger in scope but are not reflected in the CIB workload. The investigations entered into by the CIB resulted in 32 entries on the Provincial Major Cases Management Database and 32 ViCLAS books being submitted.

Leamington Police Service has become a more active member within the Criminal Intelligence Service of Ontario. We diligently attend district and provincial intelligence meetings as well as meeting with our law enforcement partners from the United States. With the amount of transient criminals in the region it is important to stay current with crime patterns and share intelligence with other enforcement agencies.

Forensic Services and SOCO's

Forensic Services help gather, analyze and document evidence to put before the courts.

Our Forensic Identification Officers use cameras or video, they record any evidence that may help an investigation. Their work includes documenting violent crimes, sexual assaults, robbery, arson, break and enters, drug scenes, car crashes and suspicious deaths.

Scene of Crime Officers - SOCOs lift fingerprints from crime scenes. They are also experts in assessing potential forensic items such as blood stained clothing or weapons, and lifting, preserving and packaging evidence.

USE OF FORCE REPORTING - 2008

Ontario Regulation 926/90 "*Equipment and Use of Force*" made under the Police Services Act, requires that a member of the Police Service submit a report to the Chief of Police whenever the member;

- a) draws a handgun or conducted energy weapon in the presence of a member of the public, excluding a member of the police service who is on duty;
- b) points a firearm at a person;
- c) discharges a firearm or conducted energy weapon;
- d) uses a weapon other than a firearm on another person; or
- e) uses physical force on another person that results in an injury requiring medical attention

The Leamington Police Service further breaks down the above requirements into the following more defined categories.

- a) Firearm - discharges
- b) Firearm - point at person
- c) Handgun - draw
- d) Conducted Energy Weapon
- e) Aerosol Weapon (O.C. Spray)
- f) Impact Weapon - Hard (Baton strike)
- g) Impact Weapon - Soft (Baton no strike)
- h) Empty Hand Techniques - Hard
- i) Empty Hand Techniques - Soft

During 2008 all uniformed Members of the Service successfully completed mandated "Use of Force" refresher training.

Members completed Use of Force Reports on six (6) separate incidents. These have been reviewed, and while a number of force options may have been employed during each incident, for the purposes of this report, only the highest level of force used is being reported.

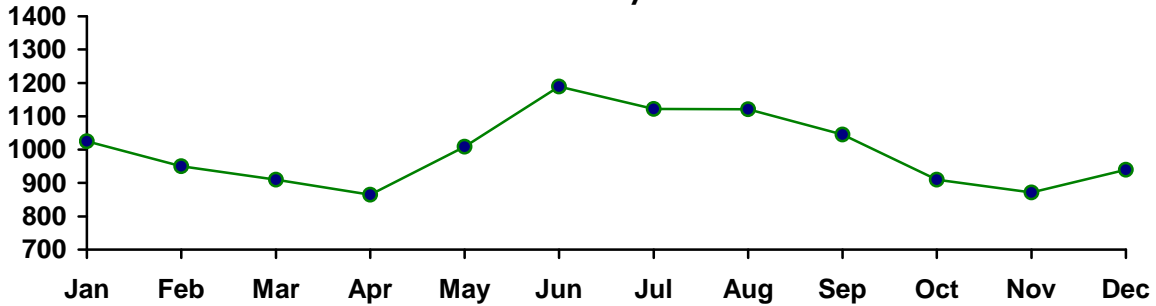

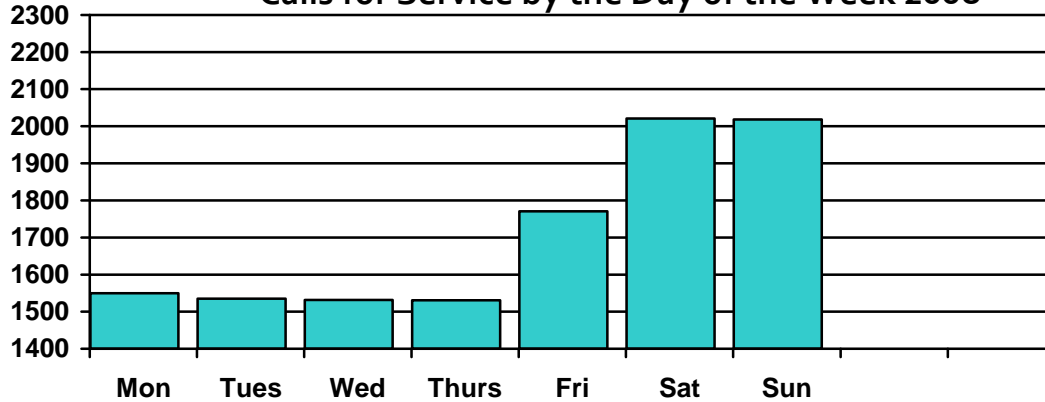

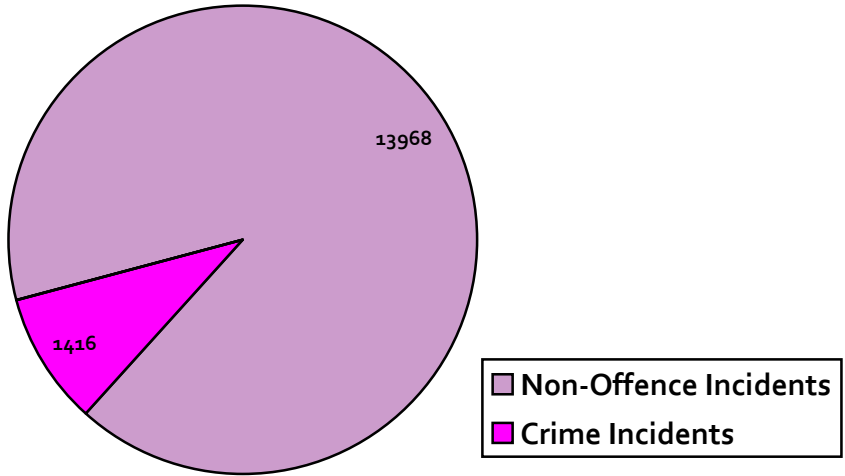
Calls for Service by Month 2008



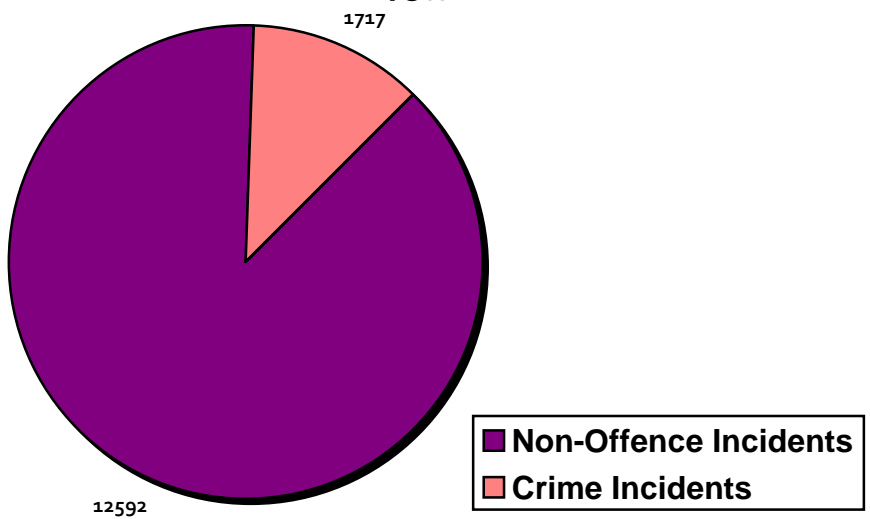
Calls for Service by the Day of the Week 2008
