



# DOG REGISTRATION

By-law 668-06

**In Summary By-law 668-06:**

- All dog registrations expire on December 31<sup>st</sup> of the year issued.
- No person shall own a dog within the municipality unless it is registered with the municipality on a yearly basis.
- No person shall keep more than two (2) dogs in a dwelling unit or on any premises.
- Every dog Owner shall remove and dispose sanitarly excrement left by their dog.
- No dog Owner shall allow their dog to run at large.
- Every dog Owner shall keep their dog under physical control by means of a leash at all times when the dog is any place other than the premises of the Owner.
- Guide dog within the meaning of the Blind Person's Rights Act, handicapped aid dogs and police service dogs are exempt from payment of registration fees.
