KENNEL OWNER

Pursuant to By-law 668-06:

1. Every kennel shall be kept in a clean and sanitary condition and free of refuse of any kind at all times so as to prevent the arising of odours therefrom, and shall be kept free of flies or vermin at all times.
2. No kennel may be established except where it is permitted under the applicable Zoning by-law in force from time to time.
3. No kennel with an outside area of confinement for dogs shall be constructed or located within sixty (60) meters of any building used for human habitation on any adjacent lot, and no outside area of confinement for dogs shall be constructed or located within three meters of any property boundary line.
4. All kennels may be subject to Inspection by the Medical Officer of Health for the Municipality and where, in his opinion, a kennel deviates from the minimum standards established by him, the Clerk shall be at liberty to revoke the registration herein granted until such time as the Clerk is notified by the Medical Officer of Health that the Kennel complies with these standards. The owner of the kennel shall have a right to appeal the revocation to Council.
