



## **Mayoral Direction (Part VI.1 of the Municipal Act, 2001)**

Purpose: Decision to Give Written Approval of By-laws Prepared for the  
March 10, 2026 Meeting of Council

Under the authority of Part VI.1 (Special Powers and Duties of Head of Council) of the Municipal Act, 2001, Section 284.11 (Veto Powers for By-laws);

The Mayor has decided as follows:

1. The Mayor will not exercise the power to veto the following By-laws, passed at the March 10, 2026, Council meeting:
  - By-law 30-26 being a by-law to Provide for the Licensing, Regulating and Governing of Taxicab Owners and Taxicab Drivers in the Municipality of Leamington. (LS-05-25, LS-18-25)
  - By-law 31-26 being a by-law to amend the Comprehensive Zoning By-law No. 890-09, as amended for the Municipality of Leamington, which pertains to the subject lands ZBA 368, 441-459 Talbot Street West. (PLA-11-26)
  - By-law 32-26 being a by-law to amend the Comprehensive Zoning By-law No. 890-09, as amended for the Municipality of Leamington, which pertains to the subject lands ZBA 371, 915 Mersea Road 5 and VL North of 915 Mersea Road 5. (PLA-12-26)
  - By-law 33-26 being a by-law to amend the Comprehensive Zoning By-law No. 890-09, as amended for the Municipality of Leamington, which pertains to the subject lands ZBA 364, 283 Seacliff Drive West. (PLA-13-26)
  - By-law 34-26 being a by-law to amend the Comprehensive Zoning By-law No. 890-09, as amended for the Municipality of Leamington, which pertains to the subject lands ZBA 370, 97-99 Seacliff Drive West. (PLA-04-26)

- By-law 35-26 being a by-law to amend By-law 01-25 being a by-law to delegate powers and duties, Sale and Disposition of Land, Agreement of Purchase and Sale. (LGL-03-26)

  - By-law 38-26 being a By-law to confirm the proceedings of the Council of the Municipality of Leamington at its meeting held March 10, 2026
