



## APPLICATION TAXICAB VEHICLE LICENSING

PLEASE COMPLETE AN APPLICATION FOR EACH VEHICLE  New  Renewal

Information/Documentation to be attached to each Application Form:

- Copy of the current passenger motor vehicle permit (ownership) issued in the Applicant's name.
- Original current Safety Standards Certificate dated no more than thirty (30) days prior to the submission of the Application.
- Copy of any work order or other documentation issued in the processing or granting of the Safety Standards Certificate.
- Current Ontario Standard Automobile Insurance Certificate and a Certificate of Insurance issued and signed by a licensed insurance broker for the Province of Ontario or an agent or employee of the insurer. Insurance for each Taxicab shall be for liability not less than \$2,000,000 per accident exclusive of interest and costs. Certificate shall include:
  - a description of the coverage;
  - the policy number;
  - the effective date;
  - the expiry date;
  - the details of the Vehicle covered;
  - a provision that the insured has no right to cancel the insurance policy without fifteen (15) days' notice to the insurance company;
  - a provision that the insurance company will provide fifteen (15) days' notice to the Municipality of any cancellation request, modification and/or involuntary cancellation.
