## The Corporation of the Municipality of Leamington

### By-law 60-18

Being a by-law to impose fees and charges  
by The Corporation of the Municipality of Leamington

**Whereas** section 391 of the Municipal Act, 2001, S.O. c. 25 authorizes a municipality to pass by-laws imposing fees or charges on persons:

- a) for services or activities provided or done by or on behalf of it;
- b) for costs payable by it for services or activities provided or done by or on behalf of any other municipality or any local board; and
- c) for the use of its property, including property under its control;

and the costs included in a fee or charge may include costs incurred by a municipality related to administration, enforcement, and the establishment, acquisition and replacement of capital assets.

**And whereas** The Corporation of the Municipality of Leamington deems it advisable to create a comprehensive by-law to provide for the imposing of fees.

**Now therefore**, the Council of The Corporation of the Municipality of Leamington hereby enacts as follows:

1. That the fees as set out in Schedules A to N attached hereto and forming part of this by-law be imposed.
2. That Schedule A shall be effective on July 1, 2019.
3. That Schedules B to N, inclusive, shall be effective on January 1, 2019.
4. That the provisions of this by-law conflict with any other by-law of the Corporation previously passed, then the provisions of this by-law shall prevail.
5. That Schedule A to B, inclusive, of By-law 13-18 and By-law 29-18, as amended, shall be repealed as of June 30, 2019.

6. That Schedules C to M, inclusive, of By-law 13-18, as amended, shall be repealed as of December, 2018.

Read a first, second and third time and finally enacted this 9th day of October, 2018.
